Keynote Speaker



Professor Karthy Govender

Former Human Rights Commissioner, Advocate, Arbitrator and Law Professor

Professor Govender holds law degrees from England, (LLB - London), from South Africa (LLB – Natal - Summa Cum Laude), and from the USA (LLM Michigan). He is a barrister of the Middle Temple (England) and an advocate of the High Court of South Africa. He has litigated in constitutional and administrative law matters.

He was appointed to the South African Human Rights Commission by President Mandela in 1995 and re-appointed for a second term in 2002 by President Mbeki. Further, he is the Chairperson of the Film and Publication Appeal Tribunal and is a senior arbitrator with the South African Local Government Bargaining Council. In addition he has acted as a judge of the High Court in 2011, 2012, 2013 and 2015.

Professor Govender won a Fulbright Scholarship to the University of Michigan and was also the recipient of the Colenso Fellowship to St. John's College Cambridge. He has published in the fields of Constitutional and Administrative law and has presented papers and lectured on five continents.

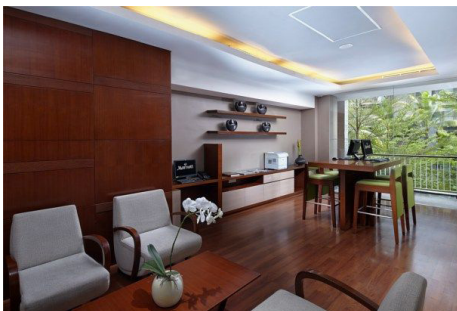
