The hotel is based near the central station (about 5 – 10 minutes walk) in the financial district and near the City Center (about 10 minutes walk).

Arrival at the airport

After arrival you will get to the hotel in the city centre by taxi or train (public transport). You will find them easily if you follow the signs.

Please note that Frankfurt has two different railway stations at the airport. They are called:

- "Regionalbahnhof" (Subway and regional trains – U- and S-Bahn) and
- "Fernbahnhof" (express trains for long distances – IC and ICE trains).

You will need extra tickets depending on using the express trains or the regional trains.

The cheaper and faster solution is to go by the regional train ("Regionalbahn"). The trains depart approximately every 15 minutes.

The distance between the airport and those railway stations and the central station is about 15 km (about 10 minutes by train or about 20 minutes by taxi).

The simpler and more expensive solution is the taxi ride (approximately 35 Euro). We recommend to take a taxi from the airport to the hotel.

Seminar

We are able to keep costs low, because all speakers who are members of the ADVOC will speak without any compensation.

The costs of the seminar on Saturday are 125 Euro per participant (included are costs for one paid speaker, drinks, coffee break and lunch).
